In addition, I also serve as a member-at-large on the Southern Plains Indian Housing Association Executive Committee. Over the past 20 years, I've helped HACN deliver housing assistance through a wide range of programs. My experience includes strategic planning, operational leadership, HR and recruitment, and visionary management. I lead with integrity and hold myself to the highest standards—striving to inspire the same in others. I bring the analytical and collaborative skills necessary to lead AMERIND forward, building consensus among diverse, and at times competing, interests.

Affordable insurance is particularly critical in high-risk areas like Oklahoma. It has been both a professional and personal milestone to help bring affordable insurance options to our people. I am proud of AMERIND's positive impact and am eager to continue contributing to its success. I look forward to strengthening our collaboration and carrying forward our tradition of excellence across Indian Country.
